# **Legislative Update: Changes to Federal Estate Tax Laws**

n December 17, 2010, President Obama signed into law the Tax Relief, Unemployment Insurance Reauthorization, and Job Creation Act of 2010. Under the Act, the federal estate tax, which went away in 2010 and was to have returned with a vengeance in 2011, is revived, but with a friendlier estate and gift tax exemption amount of \$5,000,000, and a maximum tax rate of 35%. The Act will sunset on December 31, 2012, meaning that within

two years Congress is expected to take action again. After this time, if Congress takes no further action, the estate and gift tax exemption amount will return to \$1,000,000, with a 55% maximum tax rate.

The Act replaces 2010's "modified carryover basis" rule with the former, and more favorable, "step-up" basis rule. Under 2010's modified carryover basis rules, there was limited opportunity to get a cost basis step up upon a property owner's death. Under the step-up basis rules now in place, cost basis is again stepped up to the fair market value of the asset on the decedent's date of death. The Act also allows for portability, or the ability of a surviving spouse to take advantage of his or her deceased spouse's unused exemption amount even if this is not preserved in a trust. Portability is only available to estates of decedents dying after December 31, 2010.

Estates of decedents dying in 2010 have the option of applying either: (1) the 2011 rules of an estate tax exemption amount of \$5,000,000, with a 35% maximum tax rate and step-up basis rules, or (2) the 2010 rules providing for no estate tax and

modified carryover basis. Estates below \$5,000,000 will probably elect for the new law to apply.

These changes likely will not affect the estate planning documents in place for most persons, but they do provide some new gifting opportunities for those persons with larger estates. The State of Hawaii in 2010 also adopted a separate estate tax.

#### **Did You Know**

**QUESTION:** If your insurance company refuses to pay your doctor for treatment of an injury after an auto accident, can you sue the insurance company?

Answer: Surprisingly, the Hawaii Supreme Court held in a 1998 case, <u>Wilson v. AIG</u>, that only the doctor could sue the insurance company for not paying benefits for treatment. The court ruled the policy holder was not the real party in interest because the payment was sought by the doctor. The Hawaii Intermediate Court of Appeals recently ruled in <u>Kim v. Liberty Mutual Fire Ins. Co.</u> that the Hawaii Legislature overruled the <u>Wilson</u> case. In 2006, the legislature passed Act 198, which says the doctor or the policy holder may submit a payment dispute to the Insurance Commissioner, pursue arbitration or sue in court. So now the policy holder can sue for benefits if the insurance company fails to pay the medical provider.

## **Continuing Founder's Legacy**

oday, it's a bit difficult to comprehend the impact, but in 1963, it turned heads – a law partnership between a grandson of haole missionaries from New England and the son of a Big Island sugar cane plantation worker from Japan. In the 1950s and '60s, those in power were predominantly white. Few Asian or women lawyers worked in Hawaii law firms, and none were partners in larger firms.

Damon and Shigekane became one of the first interracial law firms in Hawaii. Cyril Francis "Frank" Damon Jr. and Henry Shigekane had met while attending Yale University. They became friends and, years later, after their legal careers initially took different directions, in 1963 they formed a unique partnership. While Henry retired from the firm in 1978, Frank continued to serve clients in the estate planning practice area for many years and, on occasion, still comes to the office.

That uncommon partnership still influences our firm today, now known as Damon Key Leong Kupchak Hastert. We pride ourselves on our ability to recognize and understand different viewpoints, and to extend respect to each person involved in the process. We have always fought hard for our clients, but we also fight with dignity. As a result, after disputes are resolved, we often develop long-lasting positive relationships with opposing counsel and even parties.
