His litigation practice primarily involves the areas of commercial disputes and business litigation, construction disputes, land use and real estate litigation. He also represents clients in aviation, bankruptcy, employment, personal injury and insurance coverage cases. He has litigated cases in the State of Hawaii District and Circuit Courts, the Hawaii Bankruptcy Court and United States District Court for the District of Hawaii, and has handled appeals before the Hawaii Intermediate Court of Appeals, the Hawaii Supreme Court and the Ninth Circuit Court of Appeals.

Some examples of his work include:

- Class Action/Complex Litigation:

Represented defendants and plaintiffs in class actions and complex litigation in both State and Federal courts. Successfully defended software developer in a class action over Windows 98 at the circuit court and before the Hawaii Supreme Court. *Hindman v. Microsoft Corp.*, 2004 Haw. LEXIS 311 (2004). Defended multiple garment manufacturers located on Saipan in a class action in Federal court brought by temporary workers over labor conditions, prior to the transfer of the case to the USDC of the Northern Mariana Islands. Prosecuted and successfully resolved claims against the City and County of Honolulu on behalf of property owners challenging the effect of Ordinance 19-18 on legal long term rentals on Oahu. Litigated complex State and Federal cases involving RICO, anti-trust and Chapter 480 unfair

and deceptive acts and practices claims.

- Land Use Litigation:

Successfully litigated inverse condemnation and vested rights claims of property owners against State and local governments. Successfully defended the land use entitlements of the Ho'opili project before the Hawaii Supreme Court and lower courts. Defended property owners from zoning violations and lawsuits related to transient vacation rental industry. Advised clients on Army Corps and EPA wetlands matters. Represented property owners in eminent domain proceedings initiated or threatened by the State and by the counties. Represented oceanfront landowners on Maui, Oahu, Kauai and Molokai with respect to shoreline certification, shoreline setback, seawall and fish pond issues. Defended property owners in enforcement actions by State and local zoning enforcement authorities concerning clean water, grubbing, grading, and building and zoning code violations. Represented clients before numerous governmental agencies including the Board of Land and Natural Resources, the Land Use Commission, Zoning Boards of Appeal, Planning Commissions, Department of Planning and Permitting, State Historic Preservation Division, and other land use agencies.

- Construction:

- Commercial and Business Disputes:
