Shortly after graduating, she served as a Legal Assistant at Northwest Consumer Law Center, a non-profit consumer law firm in Seattle. In this position, she managed prescreening and intake of potential new clients, assisted in drafting legal documents and research for ongoing litigation cases, reviewed and prepared bankruptcy files, and revamped and assisted in managing the Pro Se Bankruptcy Clinic, for which she obtained a \$10,000 grant.

Born and raised in Everett, Washington, Kalina set her sights on a legal career from a very early age. A career quiz taken in elementary school indicated she should become a lawyer or a cosmetologist. Her parents, immigrants from Vietnam, had encouraged Kalina and her sisters to become
