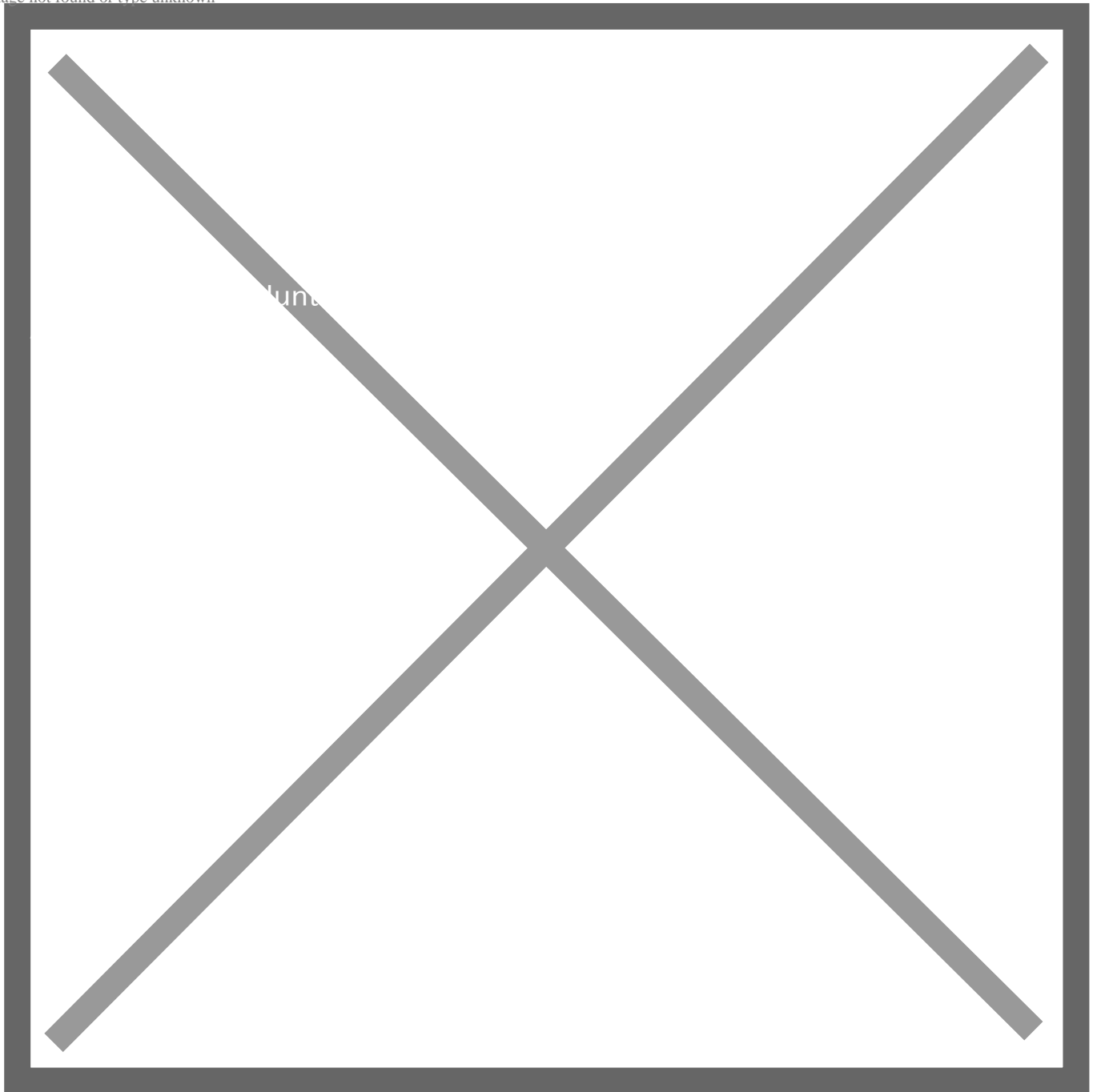

Following graduation, Brooke worked in the field of human rights and information systems for two years as a web developer and project manager to create and maintain websites and databases for prominent international projects, including the Truth and Justice Commission for Kenya and the United Nations Human Rights Council Review.

Brooke graduated from Punahou School, where she participated in varsity kayaking and varsity and club outrigger canoe paddling, steering her crew to a state championship in 2008.
