He represented veterans seeking benefits from the Department of Veterans Affairs for service-related injuries and researched veterans’ benefits law to draft petitions and letters on behalf of clients.

Serving at the Clinic was a gratifying experience for Jonathan. “We helped veterans file claims for disability compensation with the Department of Veteran Affairs,” said Jonathan. “Talking with the clients was particularly rewarding. The veterans were suffering from conditions they developed due to their service, and many of them were severely disabled. They were always so grateful for our help and it was really fulfilling to make a difference for people who truly deserved it.”

Jonathan was also a Legal Clerk with Geddy, Harris, Franck & Hickman, where he conducted legal research and wrote legal memoranda and other internal documents involving real estate, family, and contract law. He also drafted wills, easements, and other legal documents.

As a Legal Research Assistant for Professor Vivian Hamilton at William & Mary Law School, Jonathan conducted legal research, briefed law review articles, and wrote memoranda on juvenile sentencing. He also supervised and instructed undergraduate students of the William & Mary Scholars Undergraduate Research Experience program.

Jonathan earned a Bachelor of Arts, cum laude, from Davidson College in

Davidson, North Carolina, graduating with Honors in Philosophy. His Senior Honors Thesis was titled, "Can the Systems Reply Save Strong Artificial Intelligence?" While attending Davidson, he also served as the Co-Editor-in-Chief of The Davidsonian, the student newspaper.

During a time when Jonathan briefly considered going into medicine, he worked as a Medical Scribe at the University of North Carolina Physician's Network. He became involved in a pilot program that treated obesity patients in a primary care setting, as many of the patients couldn't afford specialized obesity care. "Many patients were incredibly sick due to comorbidities associated with their obesity. When the patients came to the clinic, they would talk about their lives and their problems. Some of our patients had legal concerns that needed addressing just like their medical ones. I had a great experience as a medical scribe, but my strengths being in research and writing helped me realize that I would be better suited to help people as an attorney," said Jonathan.

Jonathan was born in Ann Arbor, Michigan. At the age of two, he moved with his family to Chapel Hill, North Carolina. He graduated from East Chapel Hill High School and looks back fondly on his time growing up in a great college town. His mother grew up in Kaneohe on Oahu, providing Jonathan with an island connection and during his summers as a child, he would visit his extended family in Hawaii every year.

He is a big ice hockey fan, going to the Carolina Hurricanes games with his brother and father since he was very little. He also enjoys watching every genre of movie, but has a penchant for psychological thrillers.
